he Indiana General Assembly passed a bill towards the end of session that will prohibit fire sprinklers from being mandated in singlefamily construction in Indiana. The Indiana Builders Association was successful in advocating for SB 393, authored by Senator Eckerty (R-Yorktown) and sponsored by Representative Pressel (R-Rolling Prairie), which contained the language prohibiting fire sprinklers from being mandated in single family construction at a local or state level.

"This was a huge victory for Hoosier homeowners, as IBA members and staff urged lawmakers to keep housing affordable in the state of Indiana by keeping sprinklers as an option, not a mandate, for homebuyers", commented Pat Richard, IBA's 2018 President.

process. Fire sprinkler manufacturers, fire chiefs and others would like to have seen fire sprinklers mandated in single-family construction and lobbied lawmakers to defeat the legislation.

Hoosier homeowners could have been faced with a \$100 million dollar increase in the cost of housing per year at a minimum if sprinklers were mandated in singlefamily construction. This costly increase would have priced thousands of Hoosiers out of the ability to own a new home.

"Nothing in SB 393 will prohibit a willing buver and/or contractor from putting a fire suppression system in their home. The Indiana Builders Association strongly believes that consumers have a choice vs. a costly mandate that will benefit a few sprinkler contractors and cost Hoosiers just starting their families from attaining the dream of Homeownership", commented Rick Wajda, IBA's Chief Executive Officer. Polls across the state have overwhelmingly

shown that Hoosiers don't want fire sprinklers mandated in their home: they want the option to decide what is best for their families.

As of printing of the publication, SB 393 is awaiting signature into law by Governor Holcomb.

As Hatten faces a bunch of court appearances in the coming months, the Halls want prison time.

"I hope he gets what is due," said Keith Hall.

"There are good people in the world," said Keith Hall.

Before you hire a contractor, it's a good idea to go to Mycase.in.gov and see if that contractor has any criminal cases or civil cases pending or on their record. Make sure to use their name and their company name.

"Homeownership is the foundation of the American Dream, and it's important that homeowners feel secure when paying others to do work in and outside their home, said IBA President Pat Richard. "By adhering to a code of ethics and offering industry education and designations for our members, we aim to provide confidence for Hoosier homeowners like Keith and Carlene when they are looking for someone to help with home improvement projects." "The Indiana Builders Association is disappointed to hear of the hardships Indiana residents face when a contractor is fraudulent in their claim of providing service to a home or business

Unfortunately, some online search engines make it easy to set-up a profile even if you are not a legitimate contractor. For this reason, our organization has put together an Online Buyer's Guide for homeowners and industry professionals to connect with local builders, suppliers and contractors. This way, families like the Hall's, can know their home renovation project is done by members of an organization that fosters professionalism and dedication to the industry."



# Workforce development and Build Your Future Indiana

I t is no surprise to anyone in the construction industry that finding a worker is one of the biggest challenges we face today. With a recovering new housing market, our members are struggling to keep pace with the demand for new housing as projects are taking longer and longer to complete, due to the shortage of skilled workers in our industry.



## Midterm matters

idterm elections mean the people can elect their representatives in the middle of the term of the president, providing the opportunity to rearrange the political makeup of the U.S. Congress every two years. Unlike presidential elections where the Electoral

College determines the next president, congressional elections use the state's citizens to choose the winner.

Midterm elections will take place on November 6, 2018, with the primary held on May 8, 2018.

Voters in Indiana will elect one member to the U.S. Senate and nine members to serve in the U.S. House, one from each of the state's nine congressional districts.

•Democrats need two seats to flip Republican-led U.S. Senate and 24 seats to flip the Republican-controlled U.S. House.

While Indiana's governor is not up for election, three state executive offices are: Secretary of State, Treasurer, and Auditor. Hoosiers will also elect 25 members to

the Indiana State Senate (of the chamber's 50 seats) and all 100 members to the Indiana House of Representatives. •In Indiana, the state legislature is responsible for drawing both congressional and state legislative district lines. Winning State Senate candidates in this election will serve through 2022 and play a role in Indiana's redistricting process. Additionally there are elections held at the municipal level for judges, local public offices, and ballot initiatives.

Voting is the cornerstone of a democracy. Voting allows YOU to choose the representatives that YOU think can best effect the changes YOU want. Simply put - don't vote and you allow someone else's vision to govern you. The health and prosperity of our communities, Indiana, and the United States depends on YOUR VOTE



# 2018 home building off to a solid start

The United States Census Bureau has released data on Indiana home building in the first month of 2018, indicating a small decrease for singlefamily construction starts for January. Single-family permits are down 10% from December 2017 when 948 permits were pulled. There were 858 permits pulled in January of 2018, a 1% decrease from January of 2017 when 868 permits were pulled.


"Although this month's data indicates just a small decrease in new construction, a larger issue faces the building industry." said Indiana Builders Association President Pat Richard. "The search for skilled-labor is a critical challenge we are hoping to overcome in the coming years as lawmakers and industry professionals make efforts to grow a highly-skilled and technical workforce."

Builder confidence in the market for newly built single-family homes remains steady in January at 72, on the National Association of Home Builders/Wells Fargo Housing Market Index (HMI). Any number over 50 indicates that more builders view sales conditions as good than poor.

"The housing outlook for 2018 is promising given increased economic development and competitive mortgage interest rates" said Indiana Builders Association Chief Executive Officer Rick Wajda. "However, with housing inventory tight for the year, builders are faced with the challenge of making supply meet increased demand." Information for February building permits will be release March 23
