IBA members & PAC-supported candidates find success

on election night

The Indiana Builders Association (IBA) members on the ballot found success on November 5 as well as numerous candidates supported by IBA's PAC, the Indiana Builders PAC. As the votes were counted across the state, all IBA members seeking election or re-election to the Indiana General Assembly were victorious.

One of the highly contested races in the state saw State Representative Dale DeVon square off in a rematch from years ago with his opponent Heidi Beidinger, in House D 5. DeVon, a home builder and Life Director of the Indian Builders Association, is a long-time member of the HB Joe Valley. His district is routinely one of the most contethe state and this year was no different. DeVon was of victorious, securing victory for another two-year term to 45%.



Lt. Gov. Suzanne Crouch receives Indiana Bunders Association's highest distinction

The Indiana Builders Association (IBA) awarded the 2024 John C. Hart Presidential Award, its highest award, to Lt. Gov. Suzanne Crouch during IBA's Annual Conference and Board of Directors Meeting.

Crouch has been a staunch ally and advocate for housing across the state of Indiana. Whether it was serving as State Auditor, State Representative, or Lt. Governor, housing issues have always been an important part of her agenda. Among many of her legislative accomplishments, IBA is particularly fond of her authorship of HB 1046 in 2011 that allows for a property tax deduction for spec homes in Indiana, and her work on HB 1575 in 2023 to recreate the Fire Prevention & Building Safety Commission.



served as Chairman of the Indiana House Ways and Means Committee in the early 1970s. Hart was known for being instrumental in restructuring Indiana's property tax system with then-Governor Doc Bowen. Hart is also the only Hoosier to serve as President of the National Association of Home Builders and one of five Hoosiers inducted into the National Housing Hall of Fame. The John C. Hart Presidential Award is reserved to a select few who have made unselfish commitment and extraordinary contributions to the industry, the Association, or to one's community. •

President's Message - Where did the time go?

As I write this, my final article as IBA President, it is mid-November and my year to serve as your State President is rapidly coming to an end. Wow how time flies. It seems like it was just a couple of weeks ago when it started. I know every past president I talked to before taking office told me it would be a fast year, but I really think they were all wrong. Fast is a big understatement.

I believe it has been a good year at IBA. Starting with the legislative session, we had some key pieces of legislation passed this year:

- HEA 1383: better defines classes of wetlands.
- HEA 1108: changes allowable slopes we can build on.
- HEA 1387: expands the definition of "economic development facilities" to include agerestricted and residential housing development and clarifies that 70% of the funding is allocated to housing infrastructure projects benefiting political subdivisions with a population of less than 50,000. The RIF legislation may be one of best new programs Indiana has created in a few years. As with any new program, it may need to be tweaked, but

all in all, a great program for our state. We have had meetings with other states wanting to copy our program.

HEA 1329: allows municipalities to utilize third party inspections.

There are others that will positively impact the housing industry moving forward, but these really help our industry. A big job well done to the legislators and to Rick and Carlie.

2024 also was a busy year for IBA on the administrative side. We reviewed our franchise fee affiliation program and updated our strategic plan. We brought together members from all over the state to serve on these committees. Both committees met several times through the first half of the year. I am proud to say, I think we have a program that can help move our association forward while keeping the state and locals all viable. There is still a lot of work to do, but I am confident we are up to the challenge. I want to thank everyone who spent their valuable time on the Franchise Fee Task Force and the Strategic Plan Task Force helping to set the direction of our association this year. It would not have been possible without your hard work.

To go along with changes to the franchise fee system, we have created some new groups within IBA.

- Torchbearer Trustees: responsible for bringing new sponsors to IBA.
- Legacy Council: brings builders together from across the state to help guide the future of the organization.
- Frankenmuth Insurance: offers discounts on insurance coverage

for your business.

I ask that we all look at these programs and do all we can to make them successful for the betterment of our association.

On a personal note, I want to thank all the local associations I visited this year for welcoming me into your Association. It has been an honor to be your President for the past year. I have learned so many things about the state that I know I would never have learned without visiting all of you.

I want to give a big thank you to all of our past Presidents. Without exception, they have been willing to share their experiences with me and to encourage future generations of leaders for the Association.

I also want to say how much I have enjoyed working with my Senior Officer team, Ryan, Marcy, and Andrew. I know our Association will be in good hands moving forward. I look forward to seeing the growth of each one of you in your roles as our future leaders.

Topher Dick named IBA's 2024 Associate of the Year



A myriad of housing and workforce development issues to address in the upcoming legislative session

The Indiana General Assembly is slated to begin its work in early January for a long session, which will run through the end of April. Legislators will consider, debate, and discuss over 1,000 pieces of legislation during the session, and they also will pass a new two-year budget for the state of Indiana.

IBA's Governmental Affairs Team will be there from the onset, making sure that the voice of housing is represented at the Statehouse. In addition to the two-year budget, which will consume a lot of legislators time during the session, especially as COVID money has now run through state government, other priority issues are beginning to surface. Property tax reduction proposals are circulating from numerous legislators, and it is safe to say that water and power infrastructure discussions are forthcoming.

As it relates to housing specific issues, IBA will seek continued funding from the General Assembly for the Build Your Future program. Our partnership with the Indiana Construction Roundtable Foundation has proven to be beneficial in raising the level of awareness of careers in the construction industry for students and parents. Their BY training programs and Construction Clubs in school systems across the state have been very well received.


IBA will also be advocating for continued funding for Indiana's Residential Infrastructure Fund (RIF). The General Assembly passed legislation in the 2023 session that created and funded the RIF. Round 1 for the fund was allocated earlier this year to the tune of over \$50 million dollars and the application process for Round 2 will conclude by the end of 2024. The RIF provides access to low interest loans for local government to build out infrastructure for single-family and multi-family housing. This is an innovative program that is now being emulated by several other states.

The housing affordability crisis nationwide is real in Indiana as well. The median new home price in Indiana is over \$460,000 in 2024, meaning 80% of Hoosier households are priced out of the market.

Policymakers at the state and local level must take a hard look at how they can ease the price of housing in their area. Government regulations make up about 25% of the cost of a house. Reducing these costs will help. Loosening architectural standards, allowing for higher density, and smaller square foot houses are good starting points. A lot of the time NIMBY's pressure local government officials to close the doors of their community once they have their slice of the American Dream. These voices can be loud. Local government officials need to have the strength and courage to allow housing of all types in their communities.

Rest assured, IBA will be working to address the above issues as well as the myriad of other issues that come up as legislators begin filing bills for the upcoming session of the General Assembly.

We are the advocates for safe and affordable housing in Indiana. Do we want to build more housing? Absolutely. We want Indiana to be a shining star across the Midwest and country. If we continue to bring more jobs and economic growth to the state, we'll need somewhere for those jobs to sleep at night! •

IBA Foundations award \$8,500 in scholarships and grants





Applications for Model and Spec Home Deductions due Jan. 15!

Due to IBA's advocacy efforts, the Model Residence Deduction and the Residence in Inventory Deduction provide a 50% deduction on the structure (not the land) for up to three models and three residences in inventory, statewide for the initial partial assessment followed by three full assessments. Applications for the deductions for 2024 must be completed and signed by the property owner and filed with the county auditor where the property is located no later than January 15, 2025.




