## LEGISLATIVE ACCOMPLISHMENTS

- Passed Residential Housing Infrastructure Assistance Program & Fund
- Passed prohibition of residential fire sprinkler mandate that saves builders approx. **\$7,000/home**
- Passed prohibition on local builder license and registration requirements
- Passed Right to Work law and repealed Common Construction Wage law
- Defeated employee classification
- Passed Developers Discount statute
- Passed property tax breaks
- Passed inclusionary zoning prohibition
- Passed State Plan Review changes
